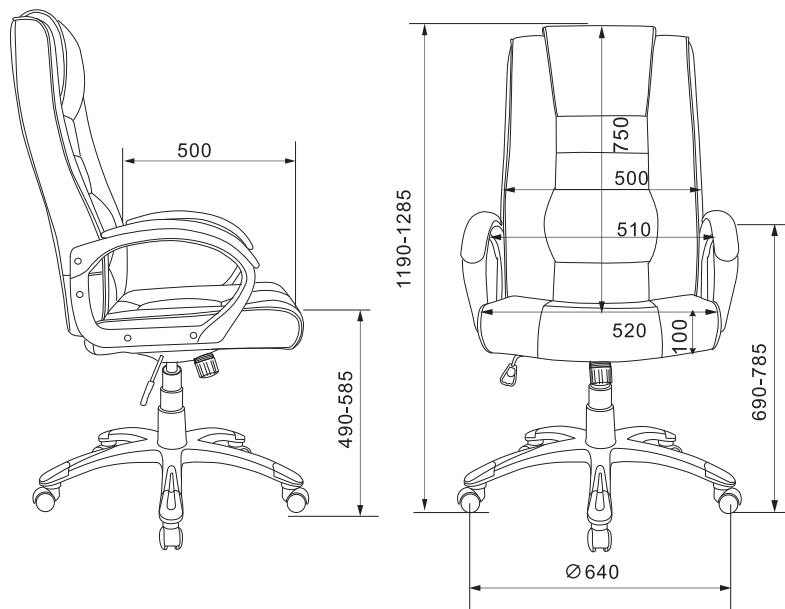

Rules and Conditions for Installation, Storage, Transportation, Sale (Distribution), and Disposal
