Intended Use

The desk is designed to provide comfortable working conditions.

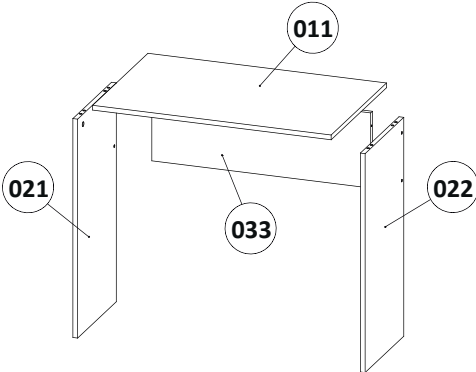
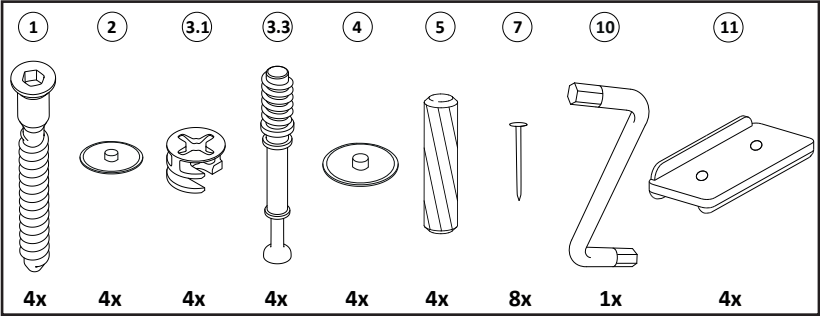
Safety Precautions

- Use the product only for its intended purpose.
- Do not exceed the maximum weight capacity
- Assemble the product strictly in accordance with the supplied user manual.
- Avoid direct sunlight on the furniture. Prolonged direct sunlight on certain areas may cause discoloration.
- Extreme heat or cold, as well as sudden temperature changes, may seriously damage the furniture or its parts.
- Place the product at a distance of at least 1 meter from heating appliances and heat sources.
- Do not place hot objects on the furniture.
- Avoid using the product in conditions of extreme humidity or dryness for extended periods, especially if these conditions alternate frequently. Over time, this may affect the integrity of the furniture. If such conditions occur, ventilate the room regularly and use dehumidifiers or humidifiers as needed to normalize humidity levels.
- Do not place the furniture near damp or wet walls and objects.
- Do not stand or jump on the furniture, and avoid subjecting it to excessive dynamic loads.
- Periodically check the tightness of the screw connections of the transformation mechanisms and tighten them if necessary.
- Avoid contact with caustic or abrasive substances. Use specialized cleaning agents for furniture care. Damp wiping is allowed, provided that moisture is removed afterward.

Maintenance and Care

- Always keep furniture surfaces completely dry. If necessary, wipe surfaces with a soft, dry cloth (flannel, felt, wool, etc.).
- It is recommended to clean the furniture as soon as possible after it becomes dirty. If you leave stains for some time, the risk of streaks, spots, and damage to the furniture coating or its parts increases significantly.
- For stubborn stains, it is recommended to use specialized cleaners that are suitable for the type of finish on your product.

Odor

New furniture may emit a natural odor from the materials it is made of. The odor may persist for up to 3 weeks after assembly. To reduce the intensity of the odor, it is recommended to:

- For upholstered furniture: Vacuum the product and ventilate the room.
- For case furniture: Wipe with a cloth dampened with a mild detergent, wipe dry with a clean cloth, and ventilate the room, opening all doors and drawers of the product.

These steps should be repeated 3–4 times a day.

Rules and Conditions for Installation, Storage, Transportation, Sale (Distribution), and Disposal

- The device must be stored in its original packaging, on heated premises, both at the manufacturer’s and at the consumer’s sites. The ambient temperature should be between +5 °C and +40 °C, and the relative humidity should not exceed 80% (non-condensing). The storage area must be free from aggressive contaminants (e.g., acid or alkali vapors) that could cause corrosion.
- The device must be transported in a dry place.
- The device requires careful handling. Protect it from exposure to dust, dirt, impact, moisture, fire, and other hazards.

- Sale or distribution of the product must be carried out in accordance with local legislation.
- Disposal of this device must be carried out in accordance with local waste recycling regulations. By ensuring proper disposal of this product, you help prevent potential harm to the environment and human health resulting from uncontrolled waste disposal and promote the sustainable reuse of material resources.
