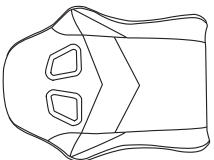
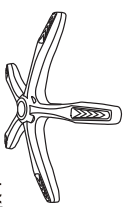
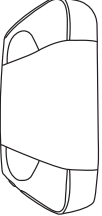
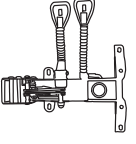
Intended Use

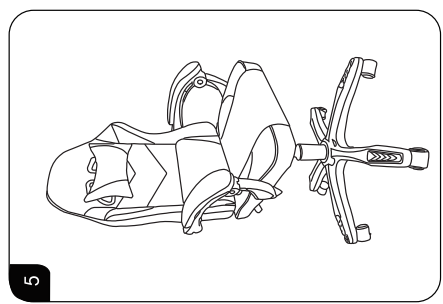
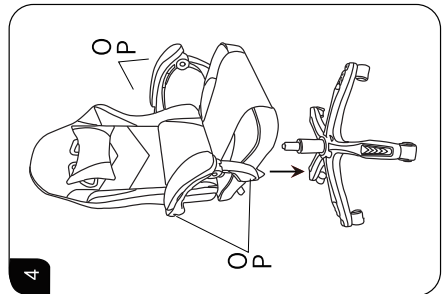
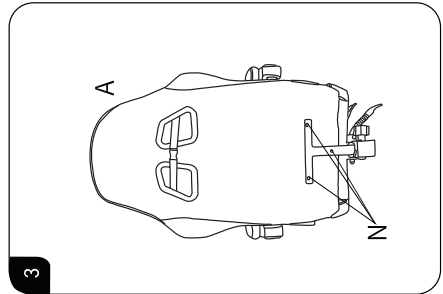
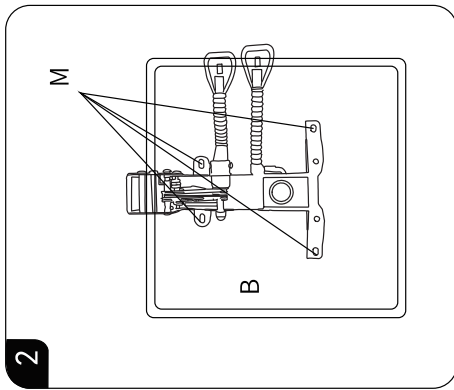
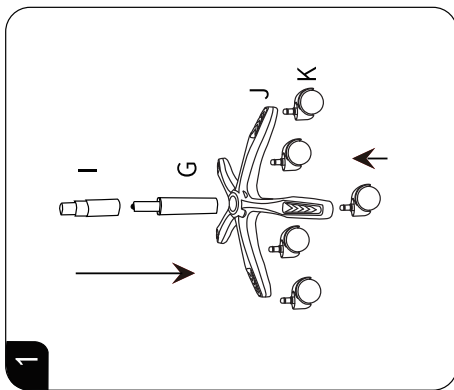
The chair is designed to provide comfortable working conditions.

Safety Precautions

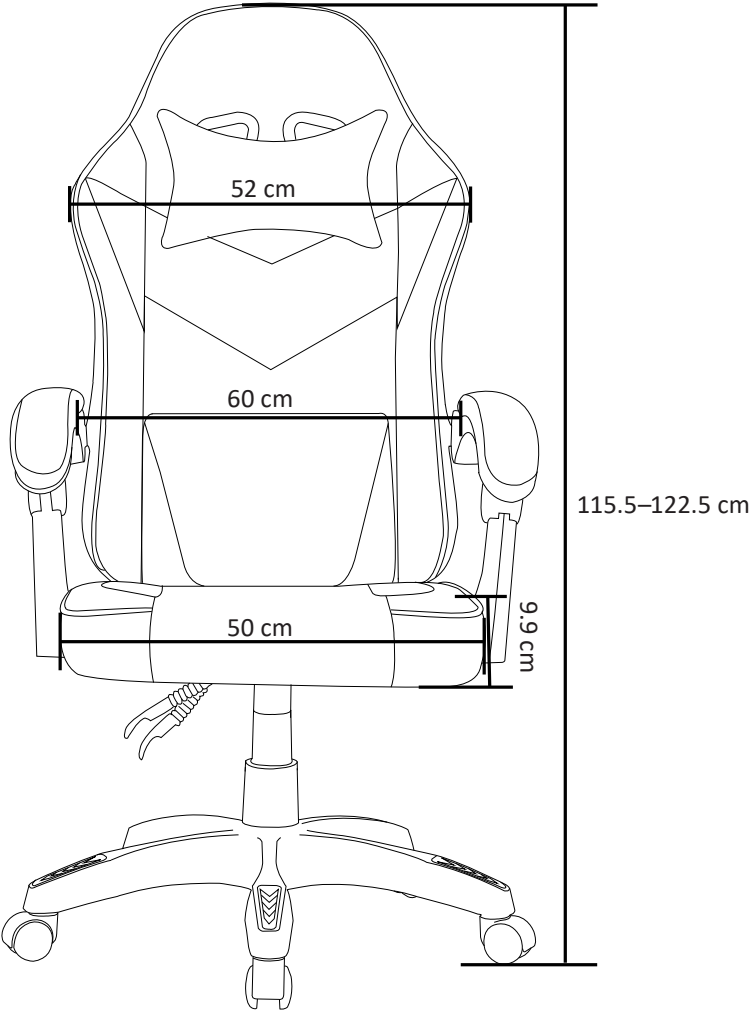
- Do not place a load on the chair that exceeds its maximum weight capacity.
- When using the chair near heating appliances, the surface must be protected from heat during operation. The temperature of heated furniture elements must not exceed +40 °C.
- Do not use the chair near an open flame.
- During use, avoid getting water or other liquids on parts of the chair that come into contact with the floor.
- Assemble the product strictly in accordance with the supplied instructions.
- If delivered during cold weather (at air temperatures below 0 °C), allow the chair to acclimate in a room-temperature environment for 2 hours before assembly to prevent plastic cracks and gas lift malfunctions.
- Chairs and seating should be used in a ventilated room with an air temperature of at least +10 °C and a relative humidity of 60–70%.
- Regularly check the fastenings of the chair parts (backrest, armrests); tighten the screws if necessary.
- Do not stand on the chair seat, as this may cause falls and injury.
- Before using the chair for the first time, check that all mechanisms are functioning properly.
- Avoid direct sunlight, placement near heating appliances, damp or cold walls to prevent deterioration of appearance and performance (stains, leather burn-through, fabric wear).
- To clean the chair, use a dry or slightly damp cotton cloth or sponge. If using cleaning agents, it is recommended to first test the product on a small, inconspicuous area to ensure it does not leave stains or cause damage. Do not use organic solvents to clean the chair.

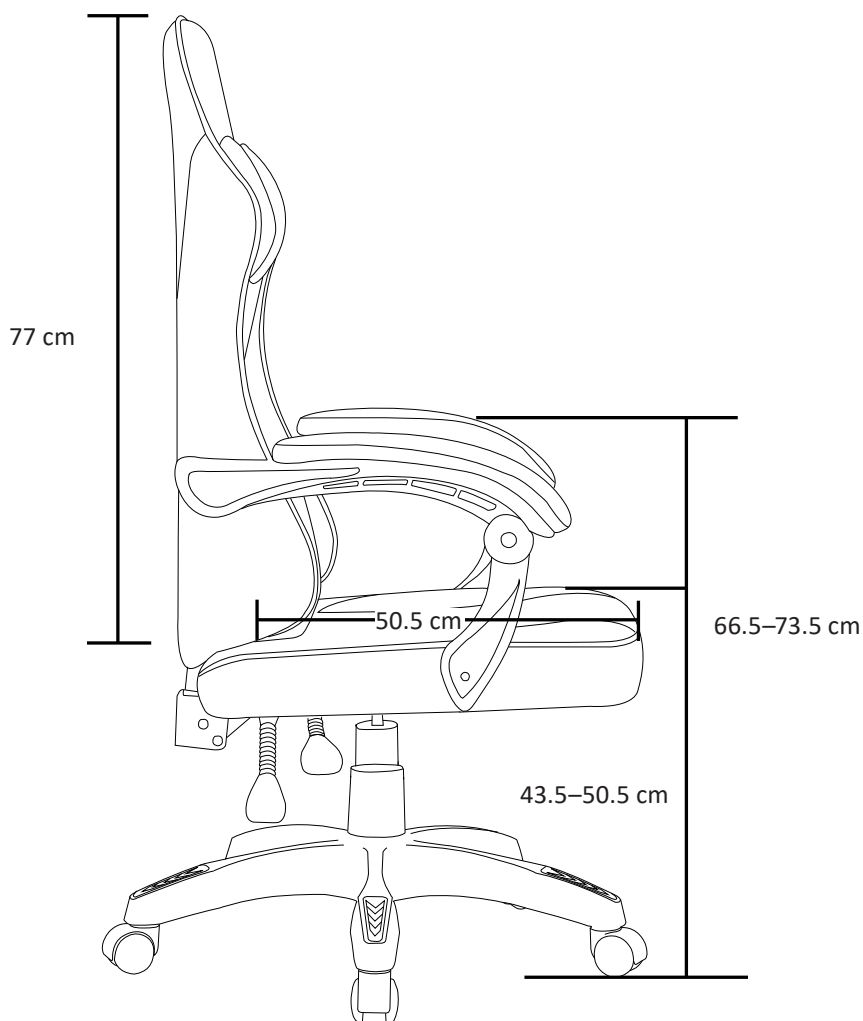
