Thank you for choosing our products.

We are pleased to offer you appliances and devices designed and manufactured to the highest standards of quality, functionality, and design. Before using the device, please read this manual carefully. It contains important information regarding your safety, as well as recommendations for the proper use and care of the product. Please keep this manual in a safe place and use it as a reference guide during future operation of the product.

Intended Use

The chair is designed to provide comfortable working conditions.

Safety Precautions

- Do not exceed the maximum weight limit.
- When using the chair in close proximity to heating appliances, its surface must be protected from heat during operation. The temperature of the furniture components must not exceed +40 °C.
- Do not use the chair near open flames.
- During operation, avoid water or other liquids coming into contact with the floor-touching parts of the furniture.
- Assemble the product strictly in accordance with the provided instructions.
- If delivered during the cold season (at air temperatures below 0 °C), allow the product to acclimate to room temperature for 2 hours before assembly to avoid cracks in plastic and malfunctions in the gas cylinder.
- Chairs must be operated in a well-ventilated room at an air temperature of at least +10 °C and a relative humidity of 60–70%.
- The fastenings of the chair components (backrest, armrests) require regular inspection. Tighten the screws if necessary.
- Do not stand on the seat of the chair, as this may cause it to tip over and result in injury.
- Before first use, check the functionality of all mechanisms.
- Avoid direct sunlight, placement near heating appliances, damp or cold walls to prevent deterioration of appearance and performance (stains, leather burning, wear of upholstery material).
- For cleaning, use a dry or slightly damp cotton cloth or sponge. When using cleaning agents, test them on a small inconspicuous area first to ensure they do not cause stains. Do not use organic solvents.

Rules and Conditions for Installation, Storage, Transportation, Sale (Distribution), and Disposal

- The installation and mounting conditions for the chair are described in the «Assembly» section of this user manual.
- The product must be stored in its original packaging, on heated premises, both at the manufacturer's and at the consumer's sites. The ambient temperature should be between +5 °C and +40 °C, and the relative humidity should not exceed 80% (non-condensing). The storage area must be free from aggressive contaminants (e.g., acid or alkali vapors) that could cause corrosion.
- The product must be transported in a dry place.
- The product requires careful handling. Protect it from exposure to dust, dirt, impact, moisture, fire, and other hazards.
- Sale or distribution of the product must be carried out in accordance with local legislation.
- Upon expiration of the product's service life, it must not be disposed of with unsorted household waste. Instead, it must be taken to an authorized collection point for electrical and electronic equipment for subsequent recycling and disposal in accordance with federal or local legislation. By ensuring proper disposal of this product, you help conserve natural resources and prevent potential harm to the environment and human health that may result from improper handling. For more detailed information about collection and disposal points for this product, please contact your local municipal authorities or your household waste disposal service.
- If product damage is detected, immediately contact an authorized service center or dispose of the product.
