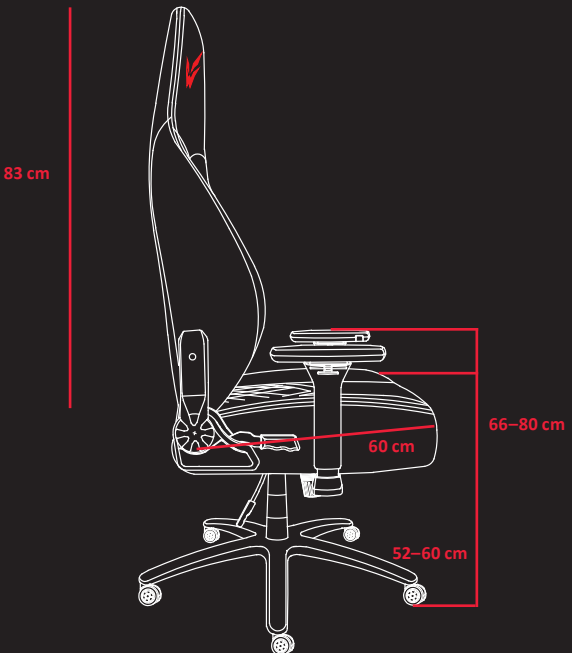
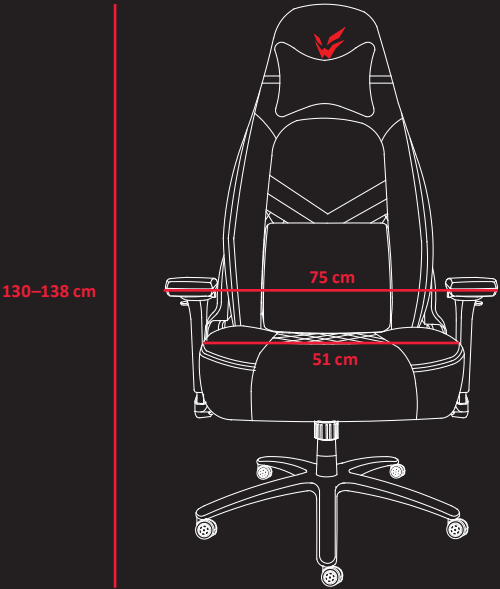
Safety Precautions

- Assemble the product strictly in accordance with the enclosed instructions.

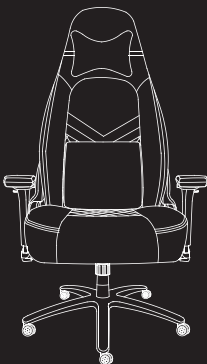
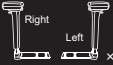
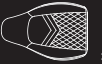
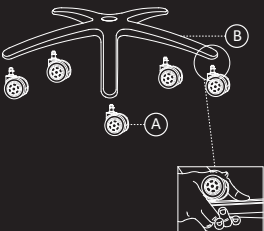
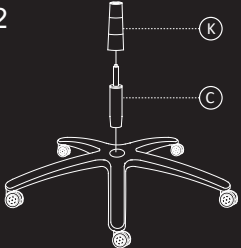
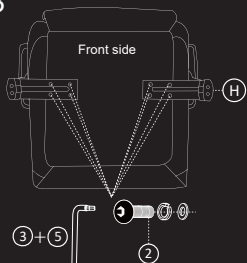
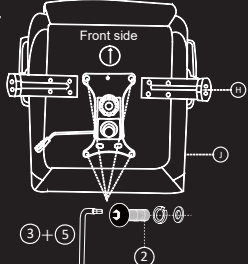
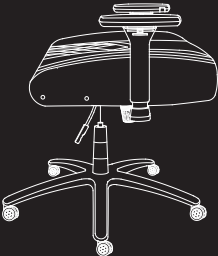
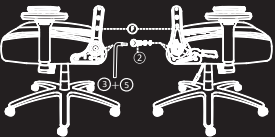
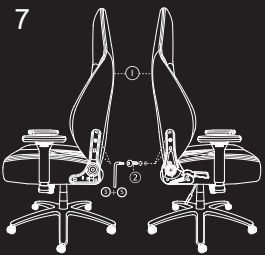
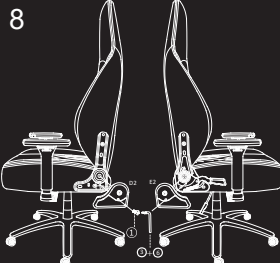
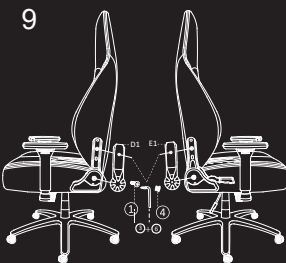
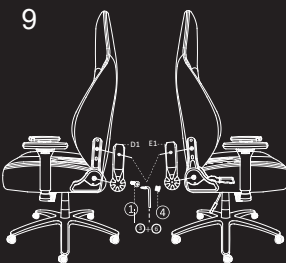
Rules and Conditions for Installation, Storage, Transportation, Sale (Distribution), and Disposal
