The chair is designed to provide comfortable working conditions.

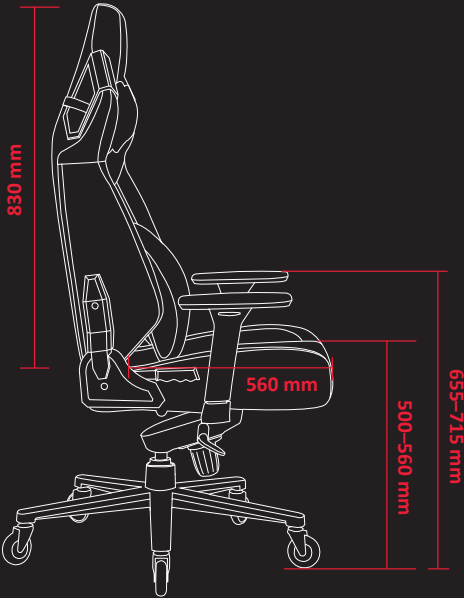
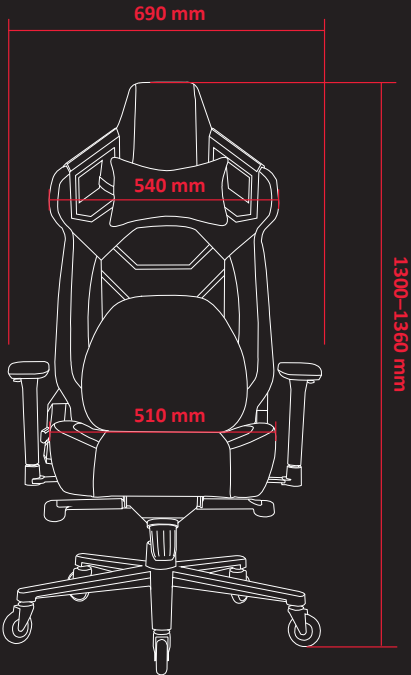
Safety Precautions

- Assemble the product strictly in accordance with the supplied instructions.

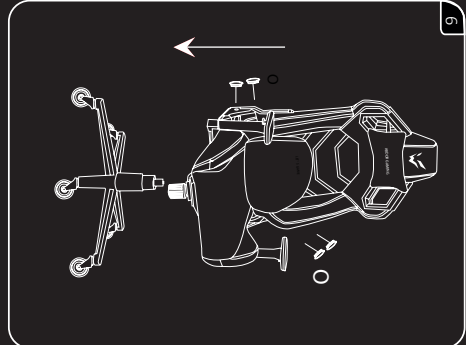
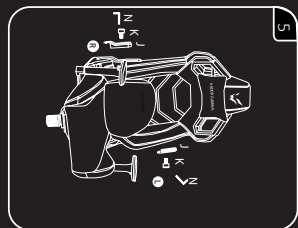
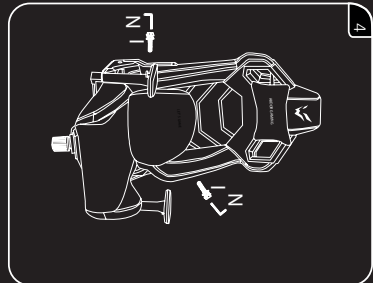
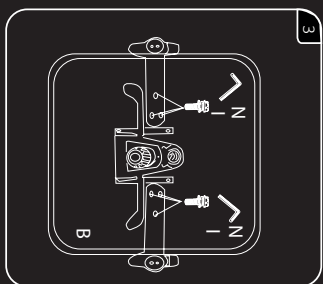
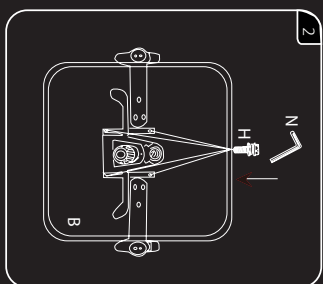
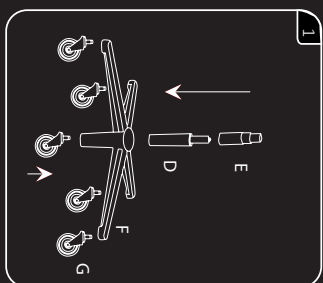
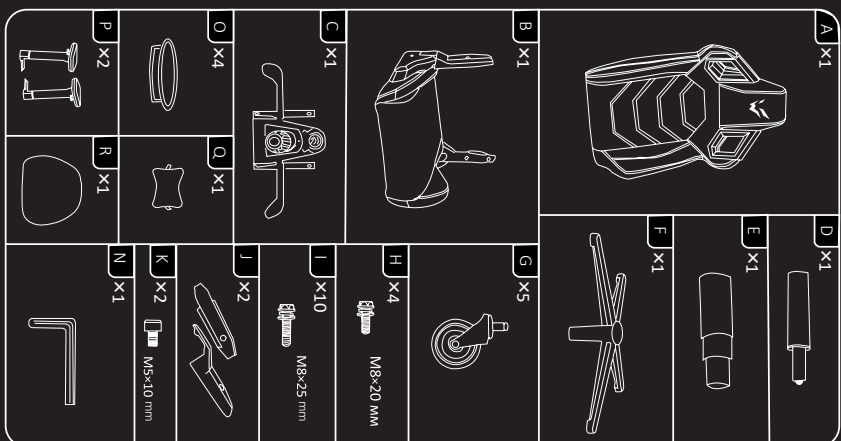
