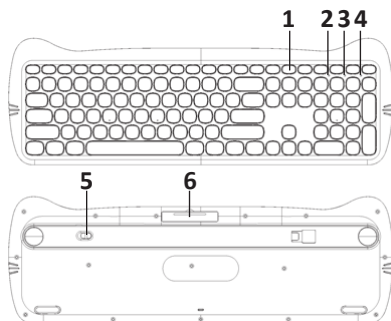

Device Diagram

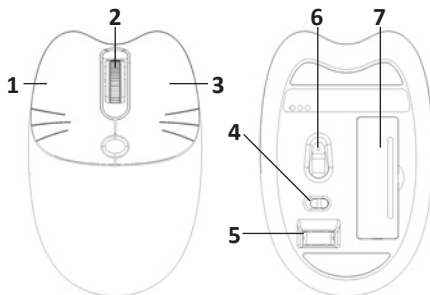
