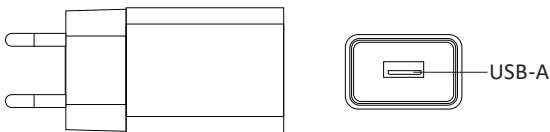
Intended Use

The wall charger is designed for charging mobile devices from an AC power supply.

Safety Precautions

- Keep the wall charger away from water and other liquids, as well as from heat sources.
- Before cleaning the charger, ensure it is disconnected from the power supply.
- Do not disassemble, drop, or shake the charger.
- Do not use the charger with damaged cables.
- Disconnect the charger from the power supply when not in use.
- This device is not intended for commercial use.
- This device is not intended for use by children or persons with reduced physical, sensory, or mental capabilities, unless they are supervised by a person responsible for their safety. Do not allow children to play with the device.
- Do not make any modifications to the device design.
- When disconnecting the device from the power supply, do not pull the connected cable.

Operating Instructions

- Connect the cable to the corresponding port on the wall charger. Connect the other end of the cable to your mobile device.
- Plug the wall charger into the power outlet.
- During operation, the device must be placed on a dry surface, away from powerful heat sources and containers with liquids.

Rules and Conditions for Installation, Storage, Transportation, Sale (Distribution), and Disposal

- This device requires no assembly or mounting.
