This car charger is designed to charge mobile devices from a vehicle's onboard power supply.

Safety Precautions

- Ensure that the power consumption of your device matches the output power of the charger.
- Do not touch the device with wet hands.
- Protect the device from moisture, intense heat, and direct sunlight.
- This device is not intended for use by children or persons with reduced physical, sensory, or mental capabilities. Do not allow children to play with the device.
- Do not use the charger if it is damaged or has damaged cables. Contact an authorized service center.
- Disconnect the unused charger from the cigarette lighter socket.
- This device is not intended for commercial use.

Operating Instructions

1. Connect the charger to the vehicle's cigarette lighter socket.
2. Connect one end of the charging cable to the corresponding port on your mobile device, and the other end to the corresponding port on the charger.

Rules and Conditions for Installation, Storage, Transportation, Sale (Distribution), and Disposal

- This device requires no assembly or mounting.
- The device must be stored in its original packaging, on heated premises, both at the manufacturer's and at the consumer's sites. The ambient temperature should be between +5 °C and +40 °C, and the relative humidity should not exceed 80% (non-condensing). The storage area must be free from aggressive contaminants (e.g., acid or alkali vapors) that could cause corrosion.
- The device must be transported in a dry place.
- The device requires careful handling. Protect it from exposure to dust, dirt, impact, moisture, fire, and other hazards.
- Sale or distribution of the device must be carried out in accordance with local legislation.
- Upon expiration of the device's service life, it must not be disposed of with unsorted household waste. Instead, it must be taken to an authorized collection point for electrical and electronic equipment for subsequent recycling and disposal in accordance with federal or local legislation.
